

LAWN MAINTENANCE

It is the primary responsibility of any owner or occupant of any lot or parcel of land to maintain any grass growing thereon at a height of not more than 6 inches. If any owner or occupant fails to assume this responsibility and after notice given by the city has not, within 7 days of the notice complied, the city may cause the work to be done and the expense thus incurred shall be a lien upon the real estate. (Ord #90.39)

Water Saving Tips at Home

Kitchen


- Soak pots and pans before cleaning instead of letting water run over them.
- Wash fruits and vegetables in a bowl of water instead of running water. The water collected can be used to water house plants.
- Thaw food in the refrigerator instead of running water for food safety and water efficiency.


Laundry

- The water level should match the size of the load
- Have full loads when doing laundry.



- Having showers that are shortened by 1 or 2 minutes will save up to 150 gallons per month.
- A leaky faucet can waste up to 5 gellons of water per day. Be sure to fix those leaks!





 Install water-saving aerators: on al faucets.



General and Outdoor

- Leave low branches on trees and shrubs to allow leaf litter to accumulate on the soil. The soil will be cooler and there will be less evaporation.
- Use nutrient rich waters collected from your fish tanks to water non-edible plants
- Use a broom instead of a hose to clean patios, sidewalks and driveways and save water.





WHERE SHOULD YOUR SUMP PUMP OR ROOF DRAIN WATER GO?????

Can water from a sump pump or roof drains go into the sanitary sewer?

The simple answer is NO!!!!!!! In the City of Osakis, it is illegal to connect your sump pump or roof drains to the sanitary sewer system (Ordinance #52.02)

During a big storm event, if homes and businesses are sending stormwater into the sanitary sewer system, the piping and treatment facility can be overloaded possibly causing sewer backups into people's homes and causing thousands of dollars to be spent on sewer system repairs.

HOW TO PROPERLY DISCHARGE A SUMP PUMP: There are two acceptable methods for discharging a sump pump.

- 1). You can have the discharge pipe empty onto your property at least 10 feet from the home. With this approach, make sure the ground slopes away from the foundation and the pipe stays clear of debris or animals. The longer the pipe the less likely the water will infiltrate through the soil and end up back into the sump pit again.
- 2). The second option is connecting the sump pump to the storm drain, which is separate from the sanitary sewer system. This approach usually requires professional installation and may require approval from the city, but completely removes the water from your property. Contact the city if you are unsure if you have a sump pump connection at your curb.



The most common sources of lead in drinking water are lead pipes, faucets and fixtures. In homes with lead pipes, that connect the home to the water main, also known as lead service lines, these pipes are typically the most significant source of lead in the water.

Lead pipes are most likely to be found in older cities and Homes built before 1986.

The City of Osakis will be doing a lead pipe inventory the summer of 2024

DOG LICENSE & ORDINANCE

All dogs are required to be licensed annually by **May** 1ST (*Ordinance 93.21*) and must have current rabies vaccination on file with the city.

License fees are: Male \$15.00 Female Spayed \$15.00 Non-Spayed \$20.00 Dog owners are asked to keep their dogs from running at large & barking habitually day or night. (*Ordinance #93.20 & 93.22*)

If violated, there is \$100.00 fine for no dog tag or if the dog is running at large.

NO VACCINATION CLINIC

There will <u>NOT</u> be a vaccination clinic this year.

Come to City Hall to purchase your dog license prior to May 1st.

Please bring with you, a current rabies vaccination notice from a veterinarian.



CITY OF OSAKIS ORDINANCES & RULES

<u>BUILDING MAINTENANCE & APPEARANCE:</u> It is the intention of the Osakis Police Dept to maintain the appearance of the City of Osakis for all the residents to enjoy. After the City-Wide Cleanup Day, the properties that remain in violation of *Ordinance #90.21* will be reviewed and subject to a citation. (see enclosed Community Housing Assistance Grant Program for information)

<u>INOPERABLE MOTOR VEHICLES:</u> Motor vehicles that are not in running order or are not legally licensed are considered an inoperable motor vehicle according to the city ordinance. Violators will be prosecuted (*Ordinance #90.20*)

RECREATIONAL VEHICLE PERMITS: Permits are issued by the Osakis Police Department.

- > One time permit fee of \$20.00
- > A copy of your insurance policy will be required.

Recreational vehicles can be driven on designated streets by permit only (Ordinance #73.12)

NUISANCE PARKING & STORAGE: The outside parking & storage on residentially-zoned property of a large number of vehicles, materials, supplies or equipment not customarily used for residential purposes is in violation. (*Ordinance #90.19*).

- > Obstructs views on streets & private property
- > Decreases adjoining landowners' and occupant's enjoyment of their property
- > Creates cluttered and otherwise unsightly areas
- > Prevents the full use of residential streets for residential parking

OSAKIS ZONING ORDINANCE: All Zoning Ordinances must be followed. Once a zoning violation has been reported, it will be investigated and if found to be a valid violation, a letter will be sent out. If the violation has not be rectified a citation may be issued. (*Chapter 153 of the Osakis Ordinances*)

CAMPFIRES: Over 3 ft x 3 ft needs to have a fire permit issued by the local Fire Warden.


OSAKIS FIRST RESPONDERS

BUILDING PERMIT

Building & Zoning permits are **REQUIRED** in the City of Osakis. Please contact city hall for information regarding our zoning ordinances, site plans, forms and permits. This information may also be found on our city website at www.cityofosakis.com.



No construction may begin without first securing a building permit from the city. If a permit is not received prior to starting the project, the permit fee will double and \$1,000.00 fine may be charged. It is always a good idea to check with City Hall prior to any work to make sure a permit it not required.

This includes approval of the building permit and payment to the city.

Every-Other-Week Commingled Recycling

Guidelines

Your recycling is single sort; you can place all items together in your container. They do not need to be sorted. Recycling cart may include the items listed below. Please set your cart out by 6:30 a.m. on collection day following these placement guidelines:

** Wheels should point toward your house, away from the street.
Cart should be 1 foot from curb, not the street. Cart should be 3 feet
from any other obstructions such as mailboxes, trees, poles, etc. No
bungee cords on the lid. IF IN DOUBT, NOTICE THE CART'S
POSITION AFTER SERVICE AND PLACE IT THE SAME WAY
EACH WEEK.

ALUMINUM AND TIN CANS – Includes small scrap pieces of clean aluminum. Labels may remain on cans.

GLASS – Please rinse. All colors of glass are accepted. Labels may remain on glass. NO BROKEN GLASS!

PLASTIC— Please rinse. Labels may remain on containers. Items with #1, #2 and #5 in the recycling triangles are acceptable.

PAPER PRODUCTS/PAPERBOARD -

This includes newspaper, ad inserts, magazines, catalogs, mixed residential mail and paperboard. (Paperboard includes items such as cereal, snack and tissue boxes as well as paper grocery bags.)

CARDBOARD— Can accept small amounts of cardboard. No pizza boxes. Please break down cardboard to prevent it from getting stuck in your container.

Please discard items not recyclable as trash.

** These items are not recyclable! **

Styrofoam containers, waxed or food contaminated paper, drinking glasses, windowpanes, light bulbs, broken glass, paper towels and aerosol cans.

AUTOMATIC WITHDRAWAL AUTHORIZATION
