Rollie Walsh:

EDA was informed that Planning & Zoning wanted the solar ordinance to come back to them for discussion.

Rollie Walsh has not agreed with anything to move forward.

Habitat for Humanity: Still working on the easement.

Marina: No update.

Engfer Property: Purchase Agreement was given to Rick Engfer two weeks ago. If signed, the next would be to work on a feasibility study. Peterson will get an update.

If approved, would need to be contingent on rezoning the property. This would need to be done to move forward.

Jason Murray will be contacted as to the funds in the account and how to utilize them after 2027 when is finalized (if they can be kept or do the funds need to be spent)

Gambling: A meeting has been scheduled for July 15th at 6 p.m. From then on, the meetings will be held quarterly on the 3rd Monday.

EDA Open Position: Asking Kurt Haakinson.

Long Prairie EDA: Meeting to discuss what options they have regarding EDA uses for housing.
