2026 City Budget

2026 Preliminary Tax Levy - The preliminary tax levy provides for the general fund, capital, and equipment replacement.

2026 Levy - The preliminary tax levy was set at \$924,190 which provides for the general fund, equipment replacement, and debt service. The levy results in an estimated increase of 5% or \$44,009, more tax collected for the City of Osakis.

2026 Budget - the general fund is the main operating fund of the City and accounts for the core services provided. Taxes are the main revenue source accounting for approximately 47.59%.

General Fund Budget Expenditures - Increased 7.2% from the 2025 Budget, due to capital costs, repair & maintenance, salaries, benefits, and liability insurance.

General Fund Revenues increased 7.2% from the 2025 Budget. Revenue sources of the increase were the Local Government Aid (LGA), Taxes, Grants, Transfers in from other funds, and Misc. Revenue.

Public Budget Meeting on 2025 Budget

The council set a preliminary levy in September, which will appear on the notice of the proposed taxes mailed to every tax payer in city limits. Staff continues to work on the 2026 Budget and will present an amended budget and final levy.

This meeting is the opportunity to provide input on the budget before it is approved for 2026. The Truth in Taxation hearing will be held on Tuesday, December 8th, 7pm at Osakis City Hall.

IMPORTANT INFORMATION

WATER METER UPGRADES

The City of Osakis is in the process of upgrading water meter batteries within the city and your water meter may be one of that needs to be upgraded.

If your water usage is being estimated, you could be paying for more than what you are using. Call today to schedule your upgrade appointment.

If you have received a letter, you need to call and schedule an appointment. Please call City Hall at 320-859-2150, to schedule a time to have your water meter battery upgraded.

The process takes 10 minutes and is done by 2 of our Public Works employees.

Appointments are available and there is no cost to the residents for the upgrade.

REMEMBER TO SHOVEL YOUR SIDEWALK

Be Osakis Nice. Clean your snow and ice.

Many people, including children, the elderly, and those using wheelchairs and strollers, depend on sidewalks all year long.

To keep Osakis' sidewalks safe and pleasant for everyone, the City of Osakis' ordinance #143 states: "no owner or occupant of any property adjacent to a public sidewalk shall allow snow and ice to remain on the sidewalk longer than 24 hours after its deposit" The City Council shall designate officials who shall remove from all public sidewalks all snow and ice as soon as possible beginning 24 hours after the snow has ceased to fall. The cost of such removal by the city shall be assessable pursuant to section 90.01 of Ordinance #143.

DETECT AND CHASE DOWN WATER LEAKS

DID YOU KNOW



The average household leaks more than 10,000 gallons of water each year or the amount of water it takes to wash 270 loads of laundry.


START YOUR CHASE WITH 3 EASY STEPS

- 1) Check your utility bill. The average family of 4 has a serious leak problem if its winter water use exceeds 12,000 gallons per month. Watch your water bill for spikes.
- 2) Check your water meter. Take a reading during a period of time when no water is being used (ie: at night) If the meter does not read exactly the same when you get up in the morning, you probably have a leak.
- 3) Take a toilet test. Put a few drops of food coloring into the tank at the back of your toilet and let it sit for 10-15 minutes. If the color shows up in the bowl, you have a leak. Make sure to flush after to avoid staining.

- Most sewer spills are preventable and are the result of misuse of the sewer system.
- Flushed baby wipes and other items cause tens of thousands of dollars in damage each year and do not break down in the sewer system.
- Flushing anything other than human waste and toilet paper down the toilet can damage household plumbing, the environment and the wastewater system.

SELLING PROPERTY IN CITY LIMITS **Inspections required prior to the sale**

Complete Ordinance can be viewed on the city website.

Effective January 1, 2025, a sump pump and sewer lateral inspection is required before selling a home in Osakis. This ensures compliance with Ordinance No. 55 Sanitary Sewers and prevents prohibited clear water discharge into the sanitary sewer system. Steps to complete:

- 1) Hire a licensed contractor to televise your sewer line.
- 2) That thumb drive must be given to the city for inspection along with a report that is filled out by the contractor
- 3) The city will make a compliance determination. If compliant, you will receive a compliance certificate. If non-compliant you will receive a letter explaining the non-compliance.
- 4) If the sump pump is not in compliance, it shall be corrected within 30 days. If it is a lateral sewer line and excavation is required the property owner shall have 90 days to correct.
- 5) Upon repairs, a second video will need to be completed and reviewed for compliance
- 6) Once a compliance determination is made, a certificate will be issued and is valid for 5 years.
- 7) Failure to comply, will result in a monthly surcharge being applied to the monthly utility bill.

WINTER PARKING REGULATIONS

Ordinance #71.01 (H)

No parking on public streets **November 1st to April 1st**, between the hours of **12:00 am to 6:00 am**, unless so otherwise marked.

Ordinance #71.03 A (1)

Whenever existing or forecasted weather conditions require that snow plowing be carried out, no person shall stop, stand or park any vehicle or permit it to stand upon any street or street right of way during periods of snow removal.

Ordinance #71.03 A (2)

ALL VEHICLES WILL BE TICKETED & TOWED FROM THE STREETS FOR SNOW REMOVAL

CITY OF OSAKIS ORDINANCES & RULES

INOPERABLE MOTOR VEHICLES: Motor vehicles that are not in running order or are not legally licensed are considered an inoperable motor vehicle according to the city ordinance. Violators will be prosecuted (*Ordinance #90.20*)

NUISANCE PARKING & STORAGE: The outside parking & storage on residentially-zoned property of a large number of vehicles, materials, supplies or equipment not customarily used for residential purposes is in violation. (*Ordinance #90.19*).

- Obstructs views on streets & private property
- Decreases adjoining landowners' and occupant's enjoyment of their property
- Creates cluttered and otherwise unsightly areas
- Prevents the full use of residential streets for residential parking



REMINDER TO DOCK OWNERS

When removing your docks & boat lifts this fall, make sure to push them out of the road right-of-way and far enough back to allow the snow plows and graders to get the snow pushed back off the roads adequately.

If someone is doing this for you, please pass on this message.



NEW UPCOMING HOUSING GRANT

The City of Osakis received a grant from MN Housing for individuals or families to build a new house in Osakis. The grant would be up to \$30,000 to be used towards building costs. This amount will be determined by the EDA. Qualifying individual or family must meet the following income guidelines:

- 1 person - \$58,950
- 2 people - \$67,350
- 3 people - \$75,750
- 4 people - \$84,150
- 5 people - \$90,900
- 6 people - \$97,650

This can be used with the \$25,000 from the Osakis EDA.


